

Official Rules for Eglin FCU Cruise on in for America's 250th Celebration Giveaway

No Purchase Necessary to Enter or Win. Entrants waive the ability to bring claims in a class action format. Winners of the Grand Prize trips must utilize cruise certificate within eighteen (18) months of date of issue or forfeit right to receive prize.

All entries, whether submitted in an Eglin Federal Credit Union branch or by mail, have an equal chance of winning.

Eligibility: Eglin Federal Credit Union Cruise Certificate Drawing ("**Cruise Drawing**") is open only to individuals who are legal permanent U.S. residents (including D.C.) that are 21 years of age or older before 07/01/2026. Void in Guam, Puerto Rico and where prohibited by law. Eglin Federal Credit Union ("Sponsor" and "Administrator"); Pacific Coast Travel Cruise and AIM Cruise Incentives ("Prize Provider"); and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers, advertising/promotion agencies and the immediate family members (i.e., spouses, parents, children, and siblings and their respective spouses) and/or those living in the same household of any of the foregoing are not eligible to enter or win. All entries become property of Sponsor and will not be returned. Released Parties are not responsible for lost, incomplete, illegible, late, misdirected, stolen, postage-due, or mutilated entries or mail; any error, omission, interruption, defect or delay in transmission, 3rd party transaction classification, transaction processing, or communication; technical or mechanical malfunctions; failures or malfunctions of phones, phone lines, or telephone systems; errors in these Official Rules, in any Cruise Drawing-related advertisements or other materials; human-processing error; failures of electronic equipment, computer hardware or software; or inaccurate entry information, whether caused by equipment, programming used in this Cruise Drawing,

Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof.
